Policy Document: Fee Structure for Diploma Programs 2024 - '25

1. Title and Applicability

- 1.1 *Title:* This document shall be known as the "Fee Structure Policy for Diploma Programs 2024-'25.
- 1.2 *Applicability:* This policy applies to those students admitted to Diploma Programs at TOMS College of Engineering, hereafter referred to as "the Institution") and to whom the scholarship is awarded.
- 1.3 Those Students to whom the scholarship is awarded and who are domiciled beyond 40 km, have to stay in the college Hostel.

2. Definitions

- 2.1 Admission Fee: All students upon admission to the Institution, have to pay Admission Fee.
- 2.2 Hostel Fee: Students staying in the Hostel have to pay Hostel fee.
- 2.3 Status Conversion: The conversion fee from Day scholar to Hosteller status and vice versa is Rs 10000/-. Those students who have not fully paid the tuition fee and availed time for payment from the college authorities, have to clear the dues of the current year, if the student opts for conversion from Hosteller to Day scholar status.

3. Fee Structure

- 3.1 *Semester Fee:* The last day for the payment of Semester Fee for odd semester is 15th June and even semester is 15th December.
- 3.2 Hostel Fee: Students who stay in hostel must pay the monthly Hostel fee before 5th of every month in advance. Any delay in payment shall carry a fine of Rs.50/- per day of default till second Saturday of every month. Thereafter the student can occupy the Hostel only after payment of all dues. It is made clear that if any student opts conversion, he has to pay full dues of current year as stated in 2.3 above.
- 3.3 E-grants Exemption: Hostel students under the E-grants scheme must also pay the Hostel fee as given above. They are exempt from Tuition Fee payment until the grant is credited to the account or for a maximum period of one year. Once the E- Grant is obtained they have to pay the Tuition Fee to the Institution without delay, lest it shall carry a fine of Rs. 50 per day after seven days of the crediting to the student's bank account. Conversion to day scholar status of E-grants' students require clearing all dues, including College Tuition Fee as in Clause 2.3.

Therefore, any student who decides to withdraw from the course midway is obligated to settle any outstanding fees of the year. The last day for the payment of Semester Fee provided by this Institution for odd semester is 15th June and even semester is 15th December.

- 4.1 *Implementation:* This policy is and is integral to the Institution's admission and registration procedures.
- 4.2 *Compliance:* Compliance is mandatory for all students.
