ORDER

As per the Order read as paper (1) above, the University granted provisional affiliation to Toms Arts and Science College, Mattakara with the programs B.Com Model I Finance & Taxation (40 seats), BCA (40 seats) & BBA (40 seats) for the academic year 2023-'24, subject to the NOC from the Government of Kerala.

As per the Government Order read as paper (2) above, the Government accorded administrative sanction to start the College 'Toms Arts and Science College, Mattakara' in the academic year 2023-24 on behalf of the management of Thirunilam Educational Trust, Mattakara P.O., Kottayam with the following programmes.

1. B Com Model 1 Finance & Taxation (40 seats)
2. BCA (40 seats)
3. BBA (40 seats)

Sanction has, therefore, been accorded by the Vice Chancellor to Toms Arts and Science College, Mattakara on behalf of the management of Thirunilam Educational Trust, Mattakara P.O., Kottayam being granted provisional affiliation with the following programs during the academic year 2023-'24.

The provisional affiliation is granted subject to the following conditions:

1. The provisional affiliation is granted initially for a period of one Academic Year only.
2. The Management shall prepare and present the students in accordance with the laws of the University for the examination and as per the approved scheme and syllabus of the University in the subjects concerned.
3. The Educational Agency shall set apart 50% of the seats of the course for being filled up by the Government or such Authority as determined by the Government on the basis of merit and reservation principles followed by the Government and the remaining 50% to be filled by the Educational Agency on the basis of merit.

a)The details of tuition fee and other fees are as detailed below:

b) Students insurance premium @ Rs.23/- per student per year.

c) Students welfare fund @ Rs. 40/- per student per year.

d) University Union fee @ Rs. 60/- per student per year.

e) Sports affiliation fee @ Rs. 240/- per student per year to be utilised in the ratio @ 50:50 by the University and the college.

f) The collection of annual administration fee from the students under any circumstances is not permitted.

g) Student's affiliation fee @ Rs. 700/- for UG courses collected on one time basis from all students shall be remitted to the university within 15 days after closing admission.

4. The rate of Tuition Fee is as per Government/University orders issued from time to time.

5. The Educational Agency shall remit Rs. 2,31,525/- (Rupees Two Lakh Thirty One Thousand Five Hundred and Twenty Five only) in Mahatma Gandhi University Fund towards initial affiliation fee for new college and also remit course affiliation fees for the above mentioned programmes.

6. The Educational Agency shall furnish a Financial Guarantee of Rs. 3,00,000/- (Rupees Three Lakh only) as provided in Mahatma Gandhi University Statutes, 1997, by way of either of the following:

- Cash Deposits
- Fixed Deposit in the State Bank of India or in any one of the Nationalized Banks, having Acquisition and Transfer of Undertaking. The Receipt being endorsed in the name of the Finance Officer, Mahatma Gandhi University.
- Government Securities.
- Saving Certificates, National, Postal or Defence Bonds in favour of the Finance Officer.
- Mortgage of the title deed of immovable property other than the College sites, buildings/hostels where such mortgage is permitted under any law for the time being in force .

7. The Educational Agency shall furnish an undertaking in stamp paper worth Rs. 100/- to the University swearing to carry out faithfully, the provisions of the Act, Statute, Ordinance and Regulations and the directions issued by the University from time to time in so far as they are related to the college, and to appoint and fix the service conditions of the teaching & non teaching staff in the college for conducting the courses as followed by the Government on conducting similar courses. The Manager of the college shall endorse the undertaking.

8. The Educational Agency will agree to collect only such fees as determined by the Government/University from time to time from the students.

9. The college shall submit the list of students admitted and remit the fees due to University within 15 days after closing admission.

10. The Educational Agency shall furnish the financial guarantee within one month from the date of sanctioning of affiliation.

11. Non-compliance with any of the above conditions would lead to the withdrawal of the affiliation without prior notice.

Orders are issued accordingly.
