ANTI-NARCOTICS POLICY

To Be Submitted by All Students at the Time of Admission

1. INTRODUCTION

TOMS College is committed to providing a drug-free academic environment. In accordance with directives from the Government of Kerala, AICTE, UGC, and the Kerala Excise Department, this Anti-Narcotics Policy has been framed to prohibit the use, possession, distribution, or promotion of narcotic substances by any student within the institution.

2. OBJECTIVES OF THE POLICY- To maintain a drug-free campus.

- To ensure the safety, health, and well-being of all students.
- To create awareness and educate students on the harmful effects of narcotic drugs.
- To comply with legal frameworks and government circulars on narcotics prevention.

3. PROHIBITED BEHAVIOUR

- Possession, use, or distribution of narcotic drugs or psychotropic substances.
- Encouraging or influencing others to use drugs.
- Association with individuals or groups involved in drug-related activities.
- Posting or promoting drug-related content on social media platforms associated with the college.

4. PREVENTIVE MEASURES

- Regular awareness campaigns, seminars, and workshops will be conducted in association with the Anti-Narcotics Cell.
- Students will undergo random checks and surprise inspections in hostels and classrooms as permitted by law.
- The Anti-Narcotics Committee will monitor and review any suspicious behaviour or reports.

5. DISCIPLINARY ACTION

- Immediate suspension pending investigation.
- On confirmation, expulsion from the institution without refund of fees.
- A police complaint shall be filed as per the Narcotic Drugs and Psychotropic Substances Act (NDPS), 1985.
- The parent/guardian will be informed immediately.

6. STUDENT DECLARATION
